Catalog Addendum

Included are updates and descriptions of programs, including degree requirements, policies, and courses available beginning 2013-2014. The addendum for 2013-2014 describes changes that apply to all students enrolling at Wilmington College for the first time during the 2013-2014 academic year.

CHANGES FOR 2013-2014 CATALOG ADDENDUM

CHANGE: pg. 5 of 2013-2014 catalog – **Per Credit Hour** (9-11 hours)

CHANGE/ADD: pg. 5 of 2013-2014 catalog – **Transcript Fee** one free released at graduation-\$10 each for others. Rushed/faxed transcripts-\$25 each.

CHANGE: pg. 36 of 2013-2014 catalog – under **1. Application for Degree #4** – After diplomas have been printed there will be a \$35.00 charge to change a diploma name.

CHANGE: pg. 38 of 2013-14 catalog should read under Course Load – "A regular full-time student registers for between 12 and 18 credit hours of courses per semester, and is expected to remain enrolled in at least 12 hours of courses per semester. Students who wish to plan an accelerated program of study may register for extra hours with the approval of their advisors. The Associate Vice President for Academic Affairs must approve all schedules with more than 18 hours. There is an extra fee for each credit hour over 18. The fee may be waived by the AVPAA if the additional hours are required as a result of the 3 to 4 credit hour change. Students wishing to have the extra credit hour fee waived should contact the AVPAA prior to registration. Generally, extra hours are recommended only if the student earned a B average in the previous semester."

ADD: pg. 54 of 2013-2014 catalog – **IX. CONSORTIUM CROSS-REGISTRION** add to end of first paragraph: Cross-registration requires academic good standing at Wilmington College and completion of prerequisites for courses chosen at another institution.

ADD: pg. 54 of 2013-2014 catalog – **SOCHE** – add **ex officio member*

REMOVE: pg. 55 of 2013-2014 catalog – **SOCHE** member – remove Miami Jacobs Career College

CHANGE: pg. 55 of 2013-2014 catalog – **GCCCU** members – under Miami University it should read: Miami University – Hamilton and Miami University – Middletown

CHANGE: pg. 55 of 2013-2014 catalog – Under **X. TRANSIENT STUDENT STATUS** last sentence should read "greater than 18 semester hours, permission from the Associate Vice President for Academic Affairs is required."

ADD: pg. 59 of 2013-2014 catalog – add Education Studies to major list

REMOVE: pages 70-73 of 2013-2014 catalog - remove "Courses other than those offered only as ✓ Pass/No Pass may not be taken on a Pass/No Pass basis in this major (minor)."

CHANGE: pg. 82 of 2013-14 catalog – "Wilmington College offers a career-technical license in Agriscience (grades 4 and beyond)."

ADD: pg. 94 of 2013-2014 catalog – **EQ330 EQUINE SCIENCE (4)**. The purpose of this course is to give a fundamental overview of the horse industry. This class will prepare the student for further study in equine areas. Students will review the historical basis of the horse, assess the diversified nature of the modern horse industry in terms of national and international economic impact. Horse behavior, anatomy and physiology, nutritional needs, and topics on health will also be covered. Students will also be involved in hands on lab projects at the Equine Center. *Prerequisite: Junior or Senior standing.*

ADD: pg. 94 of 2013-14 catalog - **EQ332 ADVANCED WESTERN HORSEMANSHIP (2)**. Advanced Western Horsemanship is designed to continue the study of elements from EQ132 and move on from basic maneuvering to a more challenging set of elements. In this course, students will gain more control working toward collection. Focus will be placed on quality of gaits, movement through and over obstacles, pattern work and consistency. A variety of events will be covered including western pleasure, trail, western riding, reining, showmanship and cattle events. *Prerequisite: EQ132.*

ADD: pg. 94 of 2013-14 catalog - **EQ333 ADVANCED ENGLISH EQUITATION (2)**. Advanced English Equitation is designed to continue the study of elements from EQ133 and move on from basic maneuvering to a more challenging set of elements. In this course, students will gain more control working toward collection. Focus will be placed on quality of gaits, movement through and over obstacles, pattern work and consistency. A variety of events will be covered including training level dressage, jumping, cross-country and hunter in hand. *Prerequisite: EQ133.*

✓ **REMOVE:** pg. 96 of 2013-14 catalog - Remove AR495 Senior Thesis Preparation (2) from list of electives in the minor
