#### Disbursement of Financial Aid to Student's Accounts

January 29, 2018 Non-accelerated & Session I only courses

March 12, 2018 Session II courses

*\*\*Students with a course(s) that is a non-accelerated/Session I and a course(s) in session II, their Federal Loans will not disburse to their account until March 12, 2018.*

#### Refund of Financial Aid

Financial Aid that is excess of student's tuition charges are refunded back to the student.

#### Non-Accelerated & Session I only courses

February 2, 2018 E-Refund Issued: Direct Deposit to a student's checking/savings account.

February 9, 2018 Paper Check Refunds are sent to student's address on file.

#### Session II Courses

March 15, 2018 E-Refund Issued: Direct Deposit to a student's checking/savings account.

March 23, 2018 Paper Check Refunds are sent to student's address on file.

*\*\*Students with a course(s) that is a non-accelerated/Session I and a course(s) in session II, their federal loan will not be disbursed until March 12, 2018. Students in this situation, that has a refund, will follow session II courses refund dates.*
