

HOUSING EXEMPTION AND HOUSING PLACEMENT TIMELINE 2020-2021

Wednesday – July 1st, 2020

Deadline for filing the Housing Exemption Application for Fall 2020. Exemptions are to be filed annually for each academic year. Beginning July 15th, the student will be considered under the Housing Contract and assigned a room on campus. Failure to accept the housing assignment, August 15th will result in the student being assessed a \$500.00 contract cancellation fee. All Contracts are for the full academic year.

**Wednesday – July 1st, 2020
Midnight**

Deadline for Room Reservation Deposit (paid via cash/check to One-Stop, Credit Cards to WILpay, \$100.00 and in **NON-Refundable**.)

NO DEPOSIT WILL BE ACCEPTED AFTER 4:00 pm in One-Stop, Students have until MIDNIGHT to pay on WILpay on Wednesday, July 1st, 2020.

All students who have not paid their \$100 deposit nor been approved for exemption from housing, will be assigned a room in the residence halls after the housing placement process is complete.

Upper-class students submitting applications for the Campus Village and College Commons, must be registered for classes.

Monday – July 6th, 2020

Deadline to apply for Commons 3-person apartments **12:00 pm**
Selection for Commons 3-person apartments starts for qualified groups **July 7th, 9am**

Thursday – July 9th, 2020

Deadline to apply for Double and Single Rooms (Returning Students) **12:00 pm**
Selection for Double and Single Rooms starts for groups, ranked by total credit hours **July 10th, 9am**

Wednesday – July 15th, 2020

Students may request room change if any spaces are available or be placed on the waiting list for a different building/hall. Both roommates must request to the Housing Office together to make any changes. Students may also be placed on a waiting list for individual VILL/CCOM openings.

Students who were assigned housing, because their exemption application was denied, or did not pay a Housing Deposit may apply to be released from housing provided residence facilities are determined to be full. Students may not be notified until *August 15th* of their release.

Residents assigned to the Village, College Commons may not be eligible for release.

Friday – July 31st, 2020

All registered students, who did not file an exemption by the deadline of Wednesday – July 1st, 2020, will be assigned a space in the residence halls. These students will be considered under the Housing Contract. Students who file an exemption after *August 15th, 2020*, and if the exemption is approved will be assessed a \$500.00 contract cancellation fee.
